RESOLUTION NO. 2015-30**

**A RESOLUTION OF THE CITY OF CLERMONT, LAKE COUNTY, FLORIDA, ADOPTING THE TENTATIVE AD VALOREM MILLAGE RATE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2015 AND ENDING SEPTEMBER 30, 2016; PROVIDING FOR COLLECTION OF TAXES; PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, a portion of the revenue for the City's 2015-2016 fiscal year general government budget must be raised from the assessment and levy of an ad valorem tax on each dollar of taxable property in the City of Clermont, Florida; and

**WHEREAS**, the gross taxable value for operating purposes not exempt from taxation within the City of Clermont has been certified by the Lake County Property Appraiser to be \$2,136,082,320 on July 1, 2015; and

**NOW, THEREFORE, BE IT RESOLVED**, by the City of Clermont of Lake County, Florida, that:

1. The 2015-2016 Fiscal Year tentative operating millage rate is 4.2061 mills which is more than the rolled-back rate of 3.5477 mills by 18.56%.
2. This resolution shall take effect immediately upon its adoption.
